# Art Soup 'Kids' Club' Art Class: Terms & Conditions

#### 1. Class Time & Place

- The class runs on a Thursday from 4-5pm.
- Children will be given a break halfway through the class and offered squash and a snack. The squash and one snack are included in the price of the class. Children are also welcome to bring their own drink and additional snack.
- The class is held at Dalgety Bay Sailing Club, The Wynd, Dalgety Bay KY11 9SJ. In the
  event that the class is to be held at a different venue for a week, attendees will be
  notified as far in advance as possible.
- The classes will break for holidays e.g. Christmas and Summer, and the dates of these breaks will be communicated in advance.

# 2. Health and Safety

- Please notify us when you request a booking if your child/ children has any health issues, allergies or learning needs that it would be useful for us to be aware of.
- We do not offer or provide any medical supervision and therefore on rare occasions, it may be that the class is not suitable for everyone.
- If a child will require a lot of additional assistance to take part in the class, we may request that you provide additional adult supervision to allow the child to fully participate and enjoy the class activities.
- To ensure safety for all participants, children should remain in the classroom for the duration of the class. They will sometimes be asked to use the sink area in the corridor to clean materials, and this area can be seen from the classroom door.
- Children can use the toilet at any time during the class and are trusted to leave the
  classroom unaccompanied to do this. We trust participants to come straight back to the
  classroom afterwards. If there are any issues surrounding this, please contact us and we
  can discuss how they can be resolved to the satisfaction of all parties involved. We will
  contact you if we need to discuss this in relation to section 10 of these terms and
  conditions.
- We ask that food is only eaten during the class break for hygiene reasons.

#### 3. Personal Belongings:

- Belongings and clothing can be left in the classroom during the class at the owners risk.
   We are not responsible for the loss or damage of these items.
- We provide aprons, and try as far as possible to ensure clothes and belongings are kept clean and safe through verbal reminders. However, arts and crafts can be messy, and we advise that participants wear short sleeves and/ or clothing that they do not mind getting messy.

#### 4. Age of Attendees

Class attendees must be aged between 7 and 11 yrs old unless agreed otherwise. This
is to ensure children can participate meaningfully in the artistic activities and can
concentrate for the length of the class.

# 5. Class Price & Payment

- The cost is £10 per class, This covers all materials and supplies for all class activities, plus juice and a snack.
- Classes are booked in a 4 week continuous block (£40 total). By agreeing to a booking, we are entering into a contract that we will supply and you will pay for 4x consecutive classes.
- Payment is due a week in advance of the upcoming 4 week block. I will send a reminder via email a week prior to payment being due. Please let me know if a situation arises where this is an issue and we can discuss payment options.
- Your child's place in the upcoming block will be secured by payment of £40 using the PayPal link provided below:

# 6. Booking and Attendance

- Attendees of the current block will have priority booking for the upcoming 4 week block.
- Previous attendees are welcome to rejoin the class at any time if a place is available at the time of enquiry.

# 7. Cancellation if you are unable to attend a booked class within a 4 week block you have already signed up for

- If your child cannot attend a class/ classes within the block you signed up for (that is, where we have provided all the classes you have paid for), you will still be charged for this class.
- If you wish to end the block before it is completed (that is, where we have provided all the classes you have paid for), we will charge you a cancellation fee equivalent to the full cost of the classes you signed up for.

#### 7. Cancellation if you wish to end the contract after the end of a 4 week block

- If an attendee chooses not to return after their current 4 week block has finished, their place will be offered to someone on the class waiting list.
- Please let me know if your child cannot attend a class or classes due to unavoidable circumstances (e.g. hospitalisation) and we may (at our discretion) be able to hold their place for you.

# 8. Cancellation if we cannot supply a class

- In the event that a class has to be cancelled, I will let all participants know as soon as
  possible via email and the cancelled class will automatically be added to the end of your
  current block of classes.
- If you cannot attend any reasonable alternative, then you may request a refund for the cancelled class.

#### 9. How and when your refund will be made

• We will make any refunds due to you as soon as possible, using the method you paid with (Paypal or bank transfer)

# 10. Our Rights to end a contract

- We may end the contract if your child breaches it. We may end the contract at any time by writing to you (via email) if:
- (a) you do not make any payment to us when it is due and you still do not make payment within 7 days of us reminding you that payment is due; or
- (b) your child acts in a disruptive manner, which we believe affects the running of a session or prejudices the safety of the other participants. This may include but not limited to for instance, not contributing to a positive atmosphere in the class, misusing materials or being disrespectful of others including appearing in the eyes of others to be bullying or intimidating other class members.
  - You must compensate us if you breach the contract. If we end the contract in the situations set out above you will remain liable to pay our charges for the remainder of the 4 week block and we will not refund you for any remaining classes if we are unable to fill the vacancy.

#### 11. In the event of permanently stopping the classes

We may write to you to let you know that we are going to stop providing the classes. We
will let you know at least one month in advance of our stopping the supply of the classes
and will refund any sums you have paid in advance for classes which will not be
provided

#### 12. Our responsibility for loss or damage suffered by you

- Please note we hold Public Liability insurance up to £2,000,000 and Professional Indemnity Insurance up to £250,000.
- We are responsible to you for foreseeable loss and damage caused by us. If we fail to comply with these terms, we are responsible for loss or damage suffered that is a foreseeable result of our breaching this contract or our failing to use reasonable care and skill, but we are not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time the contract was made, both we and you knew it might happen; for example, if you discussed it with us during the booking process.

# 13. Nobody else has any rights under this contract

• This contract is between you and us. No other person shall have any rights to enforce any of its terms.
